

- A. <u>Bid Date (Note: Responses are **bold/italicized**.)</u>
  - o Bids Due Friday, May 26, 2023 at 12 p.m. noon (No change).
- B. Contractor Questions / Comment (Note: Responses are **bold/italicized**.)
  - The BOD is Jeld-Wen "no substitutions". Is that firm? If not then we can bid an alternate. **KMA Response: The alternate windows are acceptable.**
  - Pella can provide Vinyl windows with grilles between the glass (GBG). Our grilles are contoured (not flat).

KMA Response: The contoured grilles are acceptable.

- SDL grilles (on the outside of the glass) are not offered in our Pella vinyl units.
   KMA Response: SDL grilles are not required.
- o If SDL grilles are required, then Pella could offer out lifestyle series wood windows but we might be priced out.

KMA Response: SDL grilles are not required. GC should not substitute with wood window.

- Do you know the color selection for the windows?
   KMA Response: GC to provide white interior and white exterior.
- A612 schedule calls for Vinyl, Single-Hung for Window Type-C.
   KMA Response: Window Type-C is Fixed.
- The drawing below the schedule appears to show a sliding-fixed-sliding window similar to Window Type-D.

KMA Response: Window Type-D is Sliding-Fix-Sliding.

- What flooring is going on landing in between flights of stairs? CPT4 or a matching rubber tile? Also, are the 2<sup>nd</sup> floor landing receiving CPT4?
   KMA Response: The Stair #1 landings in between flights of stairs will receive TRS-1 and provide CPT-4 on the second floor landing.
- Bid due date has no change?
   KMA Response: We will not extend the bid due date at this time.
