#### **Clarification:**

The following clarification is hereby made to the solicitation for the above project:

## General:

- 1. Bid Guarantee:
  - a. If the Bid Guarantee is a Bid Bond, an electronic copy of the completed bid bond must be included with the electronic bid submission. The original must be retained by contractor and available to the purchasing office upon request. DO NOT mail original bid bonds unless requested to do so.
- 2. To ensure timely approval, post bid interviews with the "Apparent Low" contractors for each bid category will be conducted immediately following the bid (April 11<sup>th</sup> thru April 15<sup>th</sup>). These interviews are mandatory and will require the estimator along with the project manager and/or executive associated with the project to be present. Meeting invites will be sent out the evening of Thursday 4/10/2025 following the bid. Reference the schedule below for date and time assigned to each bid category.
